STANDING ORDER 1.842

ADMINISTRATIVE ORDER

In accordance with the authority granted to this Court to accept a fixed-sum payment in lieu of the defendant's appearance and in the case as found in Fed. R. Crim. P. 58(1), it is hereby

ORDERED that in the interest of justice, efficient court administration, and effective law enforcement concerning the petty offenses listed below and occurring within the territorial jurisdiction of the United States District Court for the Western District of Louisiana, collateral in the amount prescribed below may be posted in lieu of the appearance of the offender. Upon the election of the person charged with such an offense to post said collateral in lieu of appearance before the United States Magistrate Judge for trial of said offense, the collateral in the amount listed below opposite the offense shall be forfeited to the United States. The posting of such collateral shall signify that the offender neither contests the charge nor requests a hearing before the United States Magistrate Judge and said collateral shall be administratively forfeited to the United States. If the collateral is forfeited, such action shall be tantamount to a finding of guilty.

There shall be maintained in the Office of the Clerk of Court a current list of the petty offenses and fines applicable thereto for which collateral may be accepted. Pursuant to the foregoing provisions, the offenses for which collateral may be posted in lieu of the appearance of the person charged therewith are:

Subpart A—General Prohibitions

Subpart A

§ 261.3 Interfering with a Forest officer, volunteer, or human resource program enrollee or giving false report to a Forest officer.

The following are prohibited:

(a)	Threatening, resisting, intimidating, or interfering with any forest officer engaged in or on account of the performance of his official duties in the protection, improvement, or administration of the National Forest System is prohibited.	\$500.00
(b)	Giving any false, fictitious or fraudulent report or other information to any Forest Officer engaged in or on account of the performance of his official duties knowing that such report or other information contains false, fictitious or fraudulent statement or entry.	\$350.00
(c)	Threatening, intimidating, or intentionally interfering with any Forest officer, volunteer, or human resource program enrollee while engaged in, or on account of, the performance of duties for the protection, improvement, or administration of the National Forest System or other duties assigned by the Forest Service.	\$500.00

§261.4 Disorderly conduct.

The following are prohibited when committed intentionally to cause, or recklessly to create a substantial risk of causing, public alarm, nuisance, jeopardy, or violence:

(a)	Engaging in fighting or any threatening or other violent behavior.	\$400.00
(b)	Making an utterance or performing an act that is obscene or threatening or that is made or performed in a manner that is likely to inflict injury or incite an immediate breach of peace.	\$250.00
(c)	Making noise that is unreasonable considering the nature and purpose of the conduct, location, and time.	\$125.00 (1 st Offense) \$200.00 (2 nd Offense)

§ 261.5 Fire.

The following are prohibited:

(a)	Carelessly or negligently throwing or placing any ignited substance or other substance that may cause a fire.	\$350.00

(c)	Causing timber, trees, slash, brush or grass to burn except as authorized by permit.	\$350.00
(d)	Leaving a fire without completely extinguishing it.	\$200.00
(e)	Causing and failing to maintain control of a fire that is not a prescribed fire that damages the National Forest System.	\$200.00
(f)	Building, attending, maintaining, or using a campfire without removing all flammable material from around the campfire adequate to prevent its escape.	\$150.00
(g)	Negligently failing to maintain control of a prescribed fire on Non-National Forest System lands that damages the National Forest System.	\$350.00
(h)	Possessing or using an exploding target or any kind of firework or other pyrotechnic device.	\$150.00 (Possessing) \$300.00 (Using)
(i)	Violating any State law concerning burning or fires or any State law that is for the purpose of preventing or restricting the spread of fire.	\$350.00
(j)	Operating or using any internal or external combustion engine without a spark arresting device that is properly installed, maintained, and in effective working order in accordance with USDA Forest Service Standard 5100-1.	\$100.00

§ 261.6 Timber and other forest products.

The following are prohibited:

(a)	Cutting or otherwise damaging any timber, tree, or other forest product, except as authorized by a special-use authorization, timber sale contract, or Federal law or regulation.	\$250.00
(b)	Cutting any standing tree, under permit or timber sale contract, before a Forest Officer has marked it or has otherwise designated it for cutting.	\$300.00
(c)	Removing any timber or other forest product cut under permit or timber sale contract, except to a place designated for scaling, or removing it from that place before it is scaled, measured, counted, or otherwise accounted for by a forest officer.	\$400.00
(d)	Stamping, marking with paint, or otherwise identifying any tree or other forest product in a manner similar to	\$500.00

	that employed by forest officers to mark or designate a tree or any other forest product for cutting or removal.	
(e)	Loading, removing or hauling timber or other forest product acquired under any permit or timber sale contract unless such product is identified as required in such permit or contract.	\$250.00

§ 261.7 Livestock.

The following are prohibited:

(a)	Placing or allowing unauthorized livestock to enter or be in the National Forest System or other lands under Forest Service control.	\$250.00 + \$50 per/head/day
(b)	Not removing unauthorized livestock from the National Forest System or other lands under Forest Service control when requested by a forest officer.	\$300.00
(c)	Failing to reclose any gate or other entry.	\$100.00
(d)	Molesting, injuring, removing, or releasing any livestock impounded under § 262.10 while in the custody of the Forest Service or its authorized agents.	\$500.00 + Commercial or Market Value

§ 261.8 Fish and wildlife.

The following are prohibited to the extent Federal or State law is violated:

(a)	Violating the load, weight, height, length, or width limitations prescribed by State law except by special-use authorization or written agreement or by order issued under § 261.54 of this Chapter.	\$250.00




§ 261.18 National Forest Wilderness.

The following are prohibited in a National Forest Wilderness:


(a)	Possessing or using a motor vehicle, motorboat or motorized equipment except as authorized by Federal Law or regulation.	\$250.00
(b)	Possessing or using a hang glider or bicycle.	\$250.00
(c)	Landing of aircraft, or dropping or picking up of any material, supplies, or person by means of aircraft, including a helicopter.	\$500.00

§ 261.19 Boundary Waters Canoe Area Wilderness.

The following are prohibited in the Boundary Waters Canoe Area Wilderness:

(a)	Possessing or transporting any motor or other mechanical device capable of propelling a watercraft through water by any means, except by permit or as specifically authorized by Federal law or regulation.	
(b)	Transporting, using, or mooring amphibious craft of any type or any watercraft designed for or used as floating living quarters.	
(c)	Using wheels, rollers, or other mechanical devices for the overland transportation of any watercraft, except by special use authorization, or as authorized by Federal law or regulation.	

§ 261.20 Pacific Crest National Scenic Trail.

	It is prohibited to use a motorized vehicle on the Pacific Crest National Scenic Trail without a special use authorization.

§ 261.21 National Forest primitive areas.

The following are prohibited in any area classified as a National Forest Primitive Area on September 3, 1964:

(a)	Landing of aircraft or using a motor boat, unless such use had become well established before September 3, 1964.	\$500.00
(b)	Possessing or using a motor or motorized equipment, except small battery powered, hand-held devices, such as cameras; shavers, flashlights, and Geiger-counters.	\$200.00

§ 261.22 Unauthorized use of “Smokey Bear” and “Woodsy Owl” symbol.

Nothing in the above schedule of violations is meant to preclude a federal officer or official from filing a complaint against a violator and having that violator appear before an appropriate United States Magistrate Judge. If a person charged with an offense in the schedules of this order fails to post and forfeit collateral, any punishment, including fine, imprisonment, or probation, may be imposed within the limits established by law upon conviction by plea or after trial.

This Order shall constitute the Court's policies with regard to collateral forfeiture in the listed petty offense matters and shall supplant any previous orders in that regard.
